By visiting this Web Site, and/or using the services offered on or through this Web Site, you agree to the terms of this Privacy Policy as they may be amended from time to time. As we update and expand our services, this Privacy Policy may change, so check back to this page from time to time. This Privacy Policy is incorporated into, and part of, the 'FJT Logistics Terms of Use', which governs your use of this Web Site in general. At www.fjt.com.au privacy is assured. Financial information is never stored or shared. Personal information is never shared.

Our purpose

Your privacy is a serious matter to us. In order to make your visits to our Web Site and use of the services available through our Web Site as worthwhile as possible, we may ask you for Personal Information and we may collect certain information from your computer each time you visit us. 'Personal Information' includes, for example, your name; home and/or business address; e-mail address; telephone, wireless and/or fax number; short message service or text message address or other wireless device address; instant messaging address; demographic information and/or other information that may identify you as an individual or allow online or offline contact with you as an individual. This privacy statement explains, in general, what Personal Information and other information is collected on our Web Site, how the information is used, and with whom we may share such information. Right to opt out

You have the right to "opt-out" of certain of our uses of your Personal Information. We will not share, sell or trade your Personal Information with other entities outside of FJT Logistics for marketing purposes without your permission. Please understand that if you opt-out of receiving promotional correspondence from us, we may still contact you in connection with your relationship, activities, transactions and communications with us.

Personal data we collect

We collect Personal Information from users of our Web Site, for example, through such users' activities, completion of online forms on our Web Site. Such information is collected, for example, when users register or subscribe for electronic newsletters or features on our Web Site, submit a comment or question to us using a "contact us" or similar feature on our Web Site, send us an e-mail, or in any other way submit Personal Information to us via our Web Site. You may be able to send information about our services to your friends and family members through our Web Site or in an e-mail that we have sent you. Website usage information

Cookies: We may use "cookies" to keep, and sometimes track, information about you. Cookies are small data files that are sent to your browser or related software from a Web server and stored on your computer's hard drive. Cookies track where you travel on our Web. A cookie may enable us to relate your use of our Web Site to other information about you, including your Personal Information. All of these purposes serve to improve and personalise your experience on our Web Site, to determine which areas and features of our Web Site are most popular, and to make improvements and updates to enhance the FJT Logistics Web Site experience. Most Web browsers can be set to inform you when a cookie has been sent to you and provide you with the opportunity to refuse that cookie. However, refusing a cookie may, in some cases, preclude you from using, or negatively impact the display or function of, the Web Site or certain areas or features of the Web. Website analytics refers to a set of tools used to collect and analyse anonymous usage information, enabling Us to better understand how Our Site is used. This, in turn, enables Us to improve Our Site and services offered through it. IP Address and Clickstream Data: Our server automatically collects data about your server's Internet address when you visit us. If you have an account on this site, or have left comments, you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.

Security

Protecting your information is a priority for FJT Logistics, we will take reasonable steps to protect the security and integrity of all Personal Information provided to this Web Site.

Data retention

If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Website administrators can also see and edit that information.
